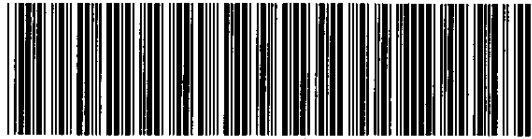

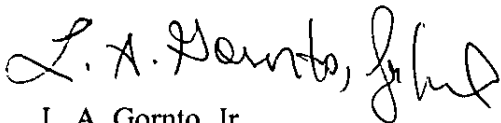

of

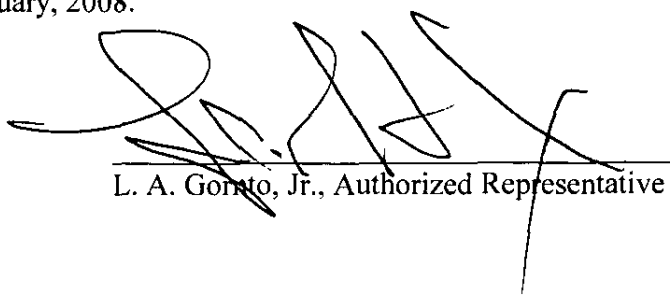

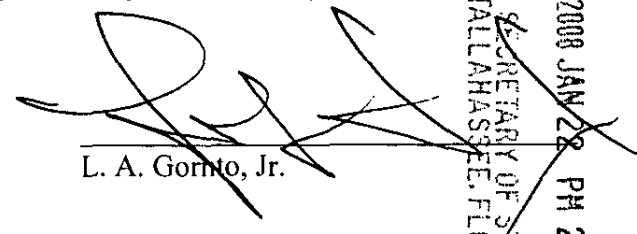
