# ARTICLES OF ORGANIZATION OF ULREY ENTERPRISES, LLC

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

#### ARTICLE I

The name of the limited liability company shall be Ulrey Enterprises, LLC.

#### ARTICLE II Address and Place of Business

The mailing address and principal place of business for the limited liability company is:

#### ARTICLE III Period of Duration

#### ARTICLE VI Management

The management of the limited liability company, unless otherwise provided in the articles of organization or the operating agreement, shall be vested in a Board of Managers.

#### ARTICLE VII Continuity of Business

Upon the death, retirement, resignation, expulsion, bankruptcy or dissolution of a member, or upon the occurrence of any other event which terminates the continued membership of a member in the limited hability company, the business of the limited liability company shall not cease and the limited liability company shall not be dissolved unless the business of the limited liability company is terminated by the consent or agreement of all remaining Members.

#### ARTICLE VIII Operating Agreement

The operating agreement shall be repeated or altered only by the members of the limited liability company, in the manner now or hereafter prescribed by the laws of the State of Florida.
