ARTICLES OF AMENDMENT**TO****ARTICLES OF ORGANIZATION OF HEALTH ASSOCIATES, PL**

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **HEALTH ASSOCIATES, PL**, a Florida professional limited liability company (the "Company"), pursuant to the Professional Service Corporation and Limited Liability Company Act (Chapter 621 of the Florida Statutes) and the Florida Revised Limited Liability Company Act (Chapter 605 of the Florida Statutes):

1. Name of Company. The name of the Company is **HEALTH ASSOCIATES, PL**.
2. Date of Filing of Articles of Organization. The Company filed its Articles of Organization with the Florida Department of State on February 12, 2008 (the "Articles").
3. Amendment to Articles of Organization.

(a) Paragraph 1 of the Company's Articles is hereby amended by deleting the current text of Paragraph 1 in its entirety and substituting the following in lieu thereof:

*"1. Name. The name of this limited liability company is **USACS of Florida, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida."*

(b) Paragraph 3 of the Company's Articles is hereby amended by deleting the current text of Paragraph 3 in its entirety and substituting the following in lieu thereof:

"3. Purpose. The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of the State of Florida."

4. Effective Date and Time. These Articles of Amendment to Articles of Organization of the Company shall be effective December 31, 2015 at 11:59 p.m. Eastern time.

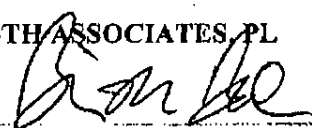
