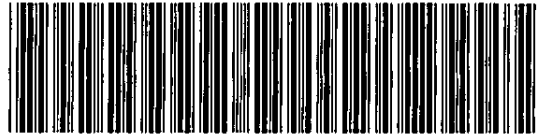

**ARTICLES OF ORGANIZATION**

1. **Name Of Company.** The name of this Limited Liability Company shall be BAC (Born Again Conservatives) "Go Fishing" Co., LLC (hereafter, "Company").

3. **Purpose Of Company.** The purpose of this Company shall be to engage in Public Relations, including Marketing & Sales.

5. **Management Of Company.** The Company is to be co-managed by the following Members of the Company:

6. **Differences, If Any, Between Members Of The Company.** If and only if there are irreconcilable differences between the Members on any significant issue affecting the success of the Company, Members shall make a good faith attempt to achieve a unanimous position. But, if a unanimous position cannot be obtained, a majority vote of the Members shall prevail.

7. **Operating Agreement.** Members agree to agree on an "Operating Agreement" in accordance with **F.S. §608.423** as a basis for anticipating and avoiding any significant differences on any matter affecting the success of the Company. On items of disagreement in the Agreement, if any, **Par. 6,** above, will apply.

8. **Net Profits.** The net profits of he Company will be distributed to Members on the basis of full time and best efforts.. If there is a difference in views by any Member(s) on the application of this standard, **Par. 6,** above, will apply.

9. **Failure To Fulfill Duties To Company And To Other Member(s).** In the event of any Member to fulfill their duties to the Company and to each other Member, **Par. 6,** above, will apply.

10. **Additional Members Of Company.** Addition of additional Members of the Company, for any reason, if any, shall be by a majority of the Members voting.
