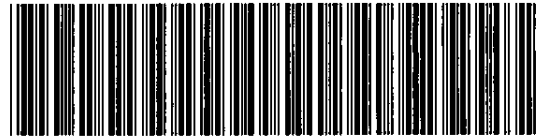

**ARTICLES OF ORGANIZATION OF

ARTICLE I – Name:
