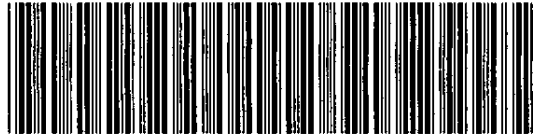



ORGANIZATION OF MMEV, LLC


THESE AMENDMENTS are made to the Articles of Organization of MMEV, LLC,
