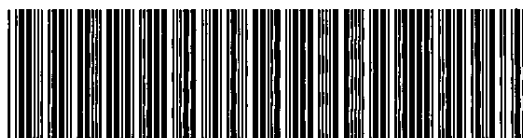

# ARTICLES OF DISSOLUTION

Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

**FIRST:** The name and address of this Company is **M.D. WEIGHT CONTROL CENTER OF DAYTONA BEACH LLC**, 16632 Southeast 2nd Lane, Silver Springs, Florida 34488.

**SECOND:** The date of the adoption of these Articles of Dissolution is 9 July 2008.

**THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421. The remaining property and assets have been distributed among its members in accordance with their respective rights and interests. There are no suits pending against the company in any court or that adequate provision has been made for the satisfaction of any judgement, order or decree which may be entered against it in any pending suit.
