1. The date of filing of the Articles of Organization was April 8, 2008, with an organizational date deemed effective October 31, 1990.

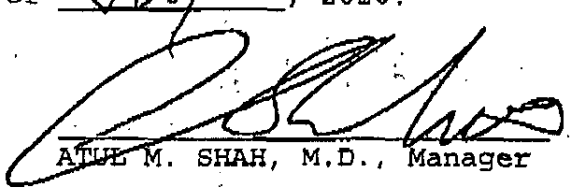
2. Article I of the Articles of Organization is hereby amended to delete the first sentence and to insert in its place the following:
