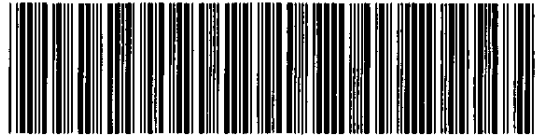

This limited liability company shall have a perpetual existence, unless dissolved according to law, effective as of the 21 day of April, 2008.


