Article I of this limited liability company's Articles of Organization is hereby amended (the "Amendment") in its entirety so as to read, after Amendment, as follows:

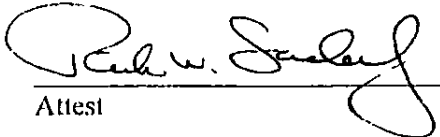

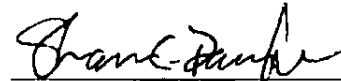
Name

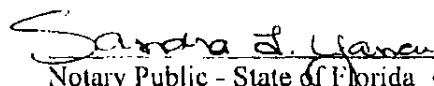

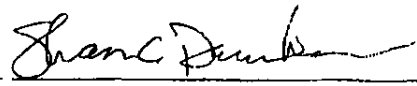
