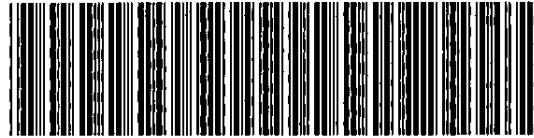

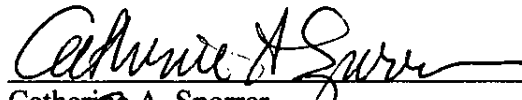
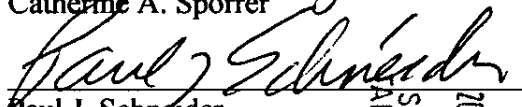
AMENDMENT TO ARTICLES OF ORGANIZATION OF SYNDOC HOLDINGS, LLC

1. Amend Article I to change the name of the limited liability company SNYDOC HOLDINGS, LLC.

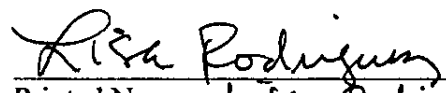
2. Adoption. This Amendment was adopted by the unanimous consent of all the managers and members entitled to vote on June 27, 2008.
