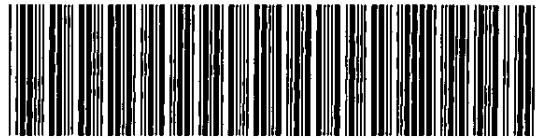

ARTICLES OF ORGANIZATION
OF
ONGUARD SENTINEL, LLC
a Florida Limited Liability Company

Article I.
Name

The name of the limited liability company is OnGuard Sentinel, LLC (the "Company").

Article II.
Duration

The Company shall have perpetual existence or until dissolved in a manner provided by law, or as provided in the operating agreement of the Company as adopted by the Members, from the date of filing of these Articles of Organization with the Secretary of State of the State of Florida.
