**ARTICLES OF ORGANIZATION FOR
THE LAW GROUP OF VALDES & CASANOVA, PL
A FLORIDA PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned Member and/or authorized representative thereof, for the purpose of forming a Florida Professional Limited Liability Company under the Florida Limited Liability Company Act, hereby adopts the following Articles of Organization.

ARTICLE I: NAME

The name of the Professional Limited Liability Company is: **THE LAW GROUP OF VALDES & CASANOVA, PL.**

ARTICLE II: PURPOSE


ARTICLE V: INITIAL REGISTERED AGENT AND ADDRESS


