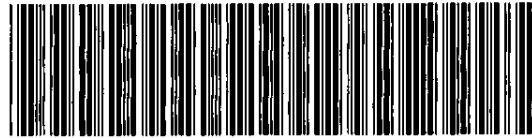

Pursuant to the requirements of Section 608.411 of the Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Amendment (Second) to the Articles of Organization of JULIAN HILLS, LLC (the "Company"), which Company was formed under the laws of the State of Florida on May 22, 2008.

1. The members of the Company have unanimously approved the changes described in the next Section to the Articles of Organization for the Company.

2. Article III, Section 1(a) of the Company's Articles of Organization shall be deleted in its entirety and the following inserted in its place:

ARTICLE III

COMPANY PURPOSE AND POWERS

Section 1. The Purpose for which the Company is formed is organized and its business carried on and the objectives to be effected by it are:

(a) To create a single asset limited liability company that owns, operates and manages that certain multifamily housing project known as Julian Hills Apartments located in Eagle Lake, Florida;

3. All other provisions of the Company's Articles of Organization shall remain in full force and effect and unaltered except as expressly provided above.

4. The foregoing amendment to the Articles of Organization was unanimously adopted by all of the members of the Company on the 12th day of March, 2012.
