ARTICLES OF ORGANIZATION

of

CRYSTAL MANAGER, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes, Chapter 608, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Crystal Manager, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 837 Old Grove Manor, Jacksonville, Florida 32207.

ARTICLE II

PURPOSES AND POWERS

TERMINATION OF EXISTENCE
