**ARTICLE I - NAME**

ARTICLE X - TERMINATION OF MEMBERSHIP INTEREST

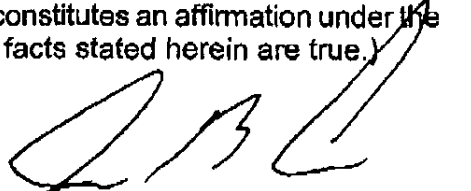

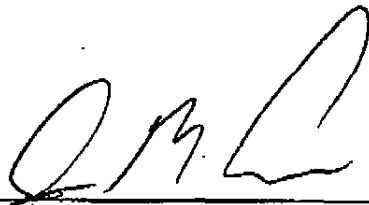
