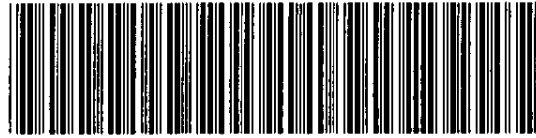

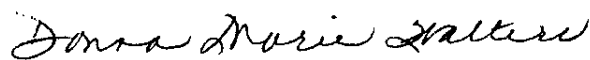

1. Article 1 of the Articles of Organization is amended to read:

Name

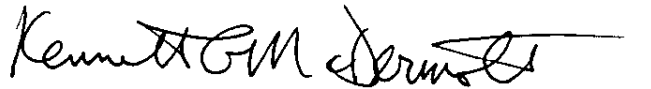
The name of the Limited Liability Company is Merry Meeting Farm, LLC.
