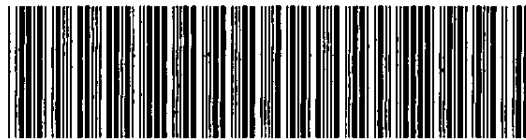



Article V


Other terms for this company's organization and management will be found in the Operating Agreement of this company, as may be amended from time to time.


