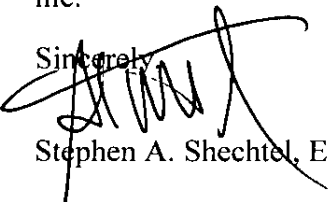

**ARTICLES OF ORGANIZATION  
BUY BUY BUSINESS, LLC**

I, the undersigned, whose post office address is: 12000 N. Bayshore Drive #302, N. Miami, Florida 33181 being at least twenty-one (21) years of age, with the intention of creating a Florida Limited Liability Company, do hereby form a Florida Limited Liability Company under the general laws of the State of Florida, and do file the following Articles of Organization:

**ARTICLE ONE  
NAME**

The name of the limited liability company is: **BUY BUY BUSINESS, LLC.**

**ARTICLE TWO  
PURPOSE**

**BUY BUY BUSINESS, LLC** is organized to:

- (a) To do any and all acts necessary for the leasing, equipping, setting up, planning, designing, guaranteeing leases, and owning, managing, and operating a consulting firm to purchase and sell businesses, including the leasing of business equipment.
- (b) To manufacture, purchase or otherwise acquire, hold, mortgage, pledge, sell, transfer or in any manner encumber or dispose of goods, wares, merchandise, implements and other personal property or equipment of every kind.
- (c) To purchase, lease or otherwise acquire, hold, develop, improve, mortgage, sell, exchange, let or in any manner encumber or dispose of real property wherever situated.
- (d) To carry on and transact, for itself or for account of others, the business of general merchandise, general brokers, general agents, manufacturers, buyers and sellers of, dealers in, importers and exporters of natural products, raw materials, manufactured products and marketable goods, wares and merchandise of every description.
- (e) To purchase, lease or otherwise acquire, all or any part of the property, rights, businesses, contracts, goodwill, franchises and assets of every kind, of any Company, co- partnership or individual (including the estate of a decedent), carrying on or having carried on in whole or in part any of the aforesaid businesses or any other businesses that the Company may be authorized to carry on, and to undertake, guarantee, assume and pay the indebtedness and liabilities thereof, and to pay for any such property, rights, business, contracts, goodwill, franchises or assets by the issue, in accordance with the laws of Florid, of stock bonds, or other securities of the Company or otherwise.
- (f) To apply for, obtain, purchase, or otherwise acquire, any patents, copyrights, licenses, trademarks, trade names, rights, processes, formulae, and the like, which might be used for any of the purposes of the Limited Liability Company; and to use, exercise, develop, grant licenses in respect of, sell and otherwise turn to account, the same.
- (g) To purchase or otherwise acquire, hold and resell shares of capital stock of any class; and to purchase, hold, sell, assign, transfer, exchange, lease, mortgage, pledge or otherwise dispose of, any shares of stock of, or voting trust certificates for any shares of stock of, or any bonds or other securities or evidences of indebtedness issued or created by, any other Company or

association, organized under the laws of the State of Florida or of any other State, territory, district, colony or dependency of the United States of America, or of any foreign country; and while the owner or holder of any such shares of stock, voting trust certificates, bonds or other obligations, to possess and exercise in respect thereof any and all the rights, powers, and privileges of ownership, including the right to vote on any shares of stock so held or owned; and upon a distribution of the assets or a division of the profits of this Company, to distribute any such shares of stock voting trust certificates, bonds or other obligations, or the proceeds thereof, among the members of this Limited Liability Company.

- (h) To have all of the powers permitted by Section 608.407 et. seq. of the Florida Statutes as amended from time to time.
- (i) To loan or advance money with or without security, without limit as to amount; and to borrow or raise money for any of the purposes of the Company and to issue bonds, debentures, notes or other obligations of any nature, and in any manner permitted by law, for money so borrowed or in payment for property purchased, or for any other lawful consideration, and to secure the payment thereof and of the interest thereon, by mortgage upon, or pledge or conveyance or assignment in trust of, the whole or any part of the property of the Company, real or personal, including contract rights whether at the time owned or thereafter acquired; and to sell, pledge, discount or otherwise dispose of such bonds, notes or other obligations of the Company for its corporate purposes.
- (j) To carry on any of the business herein before enumerated for itself, or for account of others, or through others for its own account, and to carry on any other business which may be deemed by it to be calculated, directly or indirectly, to effectuate or facilitate the transaction of the aforesaid objects or businesses, or any of them, or any part thereof, or to enhance the value of its property, business or rights.
- (k) To carry out all or any part of the aforesaid purposes, and to conduct its business in all or any of its branches in any or all States, territories, districts, colonies and dependencies of the United States of America and in foreign countries; and to maintain offices and agencies, in any or all States, territories, districts, colonies and dependencies of the United States of America and in foreign countries.
- (l) To enter into any contractual relationship, and to conduct any business in any way, so long as the Company shall not be acting in a manner contrary to law.

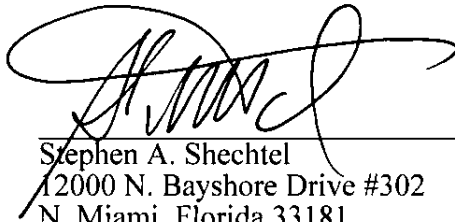
