Article I of the Articles of Organization of this Company is amended to read in its entirety as follows:

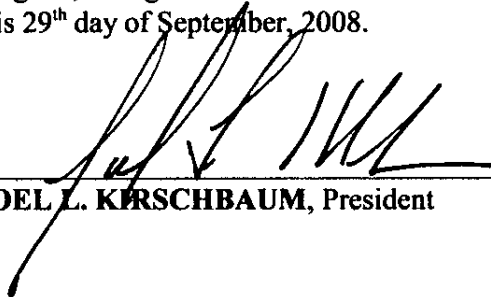
ARTICLE I
