

#### ARTICLES OF ORGANIZATION

OF

#### SOUTH PRONG RANCH, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be SOUTH PRONG RANCH, LLC. The street address of the principal office of the limited liability company in Florida shall be 11930 Walter Hunter Road, Lithia, Florida 33547, and the mailing address shall be 11930 Walter Hunter Road, Lithia, Florida 33547.

#### ARTICLE II - DURATION

The limited liability company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State.

#### ARTICLE III - PURPOSES AND POWERS

The specific purpose for which this limited liability company is organized is to conduct a cattle/calf operation, and to lease real property for such purpose. The general purpose for which the limited liability company is organized is to engage in all types of agricultural and commercial endeavors, and to transact any lawful business for which a limited liability company may be organized under


