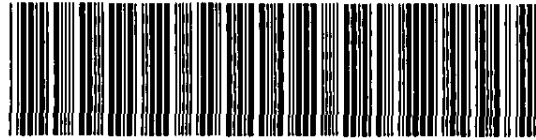

Article Three Principal Office




