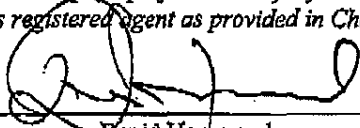
ARTICLE I. Name: The name of the Limited Liability Company is CSI REALTY SERVICES, LLC (the "Company").
