**ARTICLES OF DISSOLUTION

Pursuant to Section 605.0707 of the Florida Limited Liability Company Act (the "Act"), the Manager, as Successor Corporate Trustee of Morgan Gates Gates Gates, LLC (the "Manager") submits these Articles of Dissolution to the Florida Department of State on this 28<sup>th</sup> day of June, 2019.

1. The name of the limited liability company is **Morgan Gates Gates Gates, LLC** (the "Company").

2. The Articles of Organization were filed with the Florida Department of State on November 20, 2008 and assigned Document Number L08000107970.

3. The date the dissolution was approved by the Manager on June 28, 2019.

4. The dissolution is the result of the sale of the Tennessee Avenue Associates property, which was the only remaining asset owned by the Company.

5. All debts, obligations and liabilities of the Company have been paid or discharged.

7. There are no suits pending against the Company in any court.

8. The signature of the Manager, as both Manager and Successor Corporate Trustee is stated in these Articles approving the Dissolution.
