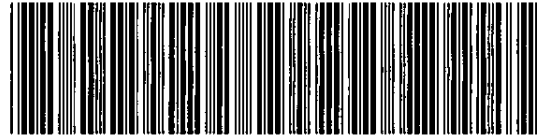

CONSENT TO AMENDMENT OF ARTICLES OF ORGANIZATION


