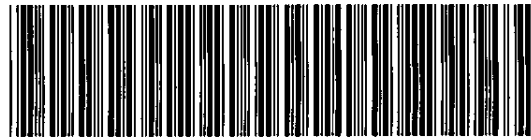

The undersigned, as a member or an authorized representative of a member of the Company pursuant to Chapter 608, Florida Statutes, files the following Articles of Organization establishing a Florida Limited Liability Company named: PINTA EUROPE, L.L.C.

ARTICLE I.

NAME

ARTICLE VI.


ADMISSION OF NEW MEMBERS


