ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF ZF DEVELOPMENT, LLC

The undersigned, as the sole Member of ZF Development, LLC, a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to the terms of Chapter 608, Florida Statutes, the Florida Limited Liability Company Act (the "Act"), states as follows:

- 1. The current name of the Company is ZF DEVELOPMENT, LLC.
2. The date of the filing of the original Articles of Organization of the Company was January 29, 2009.
3. The Articles of Organization of the Company are amended by deleting Article IV in its entirety and the following section is inserted in its place and stead:

"ARTICLE IV - Management:

All Company powers shall be exercised by or under the authority of, and the business and affairs of the Company managed under the direction of, its Managers, subject to any limitation set forth in the Operating Agreement of the Company.
