**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION
OF
JZ EXPEDITED LOGISTICS, LLC**

The undersigned sole member of JZ Expedited Logistics, LLC, a limited liability company organized and existing under the laws of the State of Florida (the "Company"), whose Articles of Organization were originally filed with the Florida Department of State on January 30, 2009, as amended from time to time, adopts the following Amended and Restated Articles of Organization of the Company:

ARTICLE I

Name

The Company reserves the right to amend, alter, change or repeal any provisions contained in these Articles in the manner now or hereafter prescribed by statute, and all rights conferred upon the members herein are subject to this reservation.

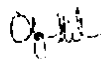
