# AMENDED ARTICLES OF ORGANIZATION OF TAMPA BAY ENT, LLC

These Amended Articles of Organization are filed in accordance with Section 608.411, Florida Statutes to amend the Articles of Organization of Tampa Bay ENT, LLC initially filed February 5, 2009 and assigned document number L09000011963. The amendments include a change of the entity's name to Tampa Bay ENT, P.L. (the "Company"), a revision of the Company's purpose, and addition of a restriction on membership as described below. The remainder of the original articles is unchanged.

#### ARTICLE I. Name

Effective as of the filing date of these Amended Articles of Organization, the name of the Company shall be **Tampa Bay ENT**, **P.L**.

# ARTICLE V. Purpose

The Company may engage in any activity or business in the practice of medicine permitted under the laws of the United States of America and of this state.

# ARTICLE X. Restriction on Membership

Membership in the Company shall be limited to individuals who are licensed as physicians in the state of Florida under Chapter 458 or 459, Florida Statutes, and entities whose membership is limited to such individuals.
