ARTICLE V - Operating Agreement

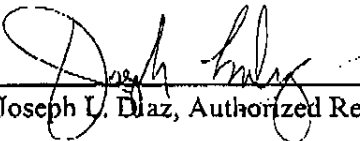

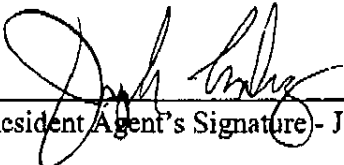
