

**ARTICLES OF ORGANIZATION**  
**OF**  
**THREE ARROWS FARM, LLC**

The Member who desires to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, by and through his authorized representative, does hereby adopt the following Articles of Organization and certify:

**ARTICLE I: NAME**

The name of the limited liability company is Three Arrows Farm, LLC (the "Limited Liability Company").

**ARTICLE II: ADDRESSES**

The mailing address of the Limited Liability Company is 11150 – 58th Street, Pinellas Park, Florida, 33782-2211. The street address of the principal office of the Limited Liability Company is also 11150 – 58th Street, Pinellas Park, Florida, 33782-2211.

**ARTICLE III: DURATION**

The period of duration for the Limited Liability Company shall commence with April 10, 2009 (the "Effective Date") and shall continue perpetually, unless terminated (i) by the unanimous vote of all Members of the Limited Liability Company, or (ii) in accordance with the Limited Liability Company's Operating Agreement, if any; provided always, however, that upon any such termination event, the existence and business of the Limited Liability Company may be continued by amendment of these Articles of Organization or the Operating Agreement providing for the continued existence of the Limited Liability Company.

**ARTICLE IV: PURPOSE**

The purpose for which the Limited Liability Company is being formed is to engage in any activity or business permitted under the laws of the United States and the State of Florida.



Any Operating Agreement (as defined in Section 608.402(24), Florida Statutes) relating to the Limited Liability Company must be in writing and signed by all of the Members.

#### **ARTICLE VII: MANAGEMENT**

The Limited Liability Company shall be conducted, carried on and managed by at least one (1) Manager, who shall be elected annually by the Members of the Limited Liability Company in the manner prescribed by and provided in the Operating Agreement, if any, of the Limited Liability Company, or the laws of the State of Florida. The Manager shall serve in this capacity until the first annual meeting of the Members or until his successor is duly elected and qualified.

#### **ARTICLE VIII: REGULATIONS**


The power to adopt, alter, amend or repeal the Operating Agreement of the Limited Liability Company shall be vested in the Members of the Limited Liability Company.

**ARTICLE IX: LIMITATION ON AGENCY AUTHORITY OF MEMBERS**



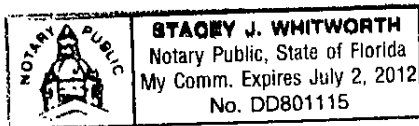
