

**AMENDED AND RESTATED ARTICLES OF ORGANIZATION  
OF

WHEREAS, on May 5, 2009, the initial articles of San Pablo Properties, LLC (the "Company") were adopted and filed with the Florida Department of State ("Original Articles"); and

WHEREAS, the members of the Company have determined that it is in their best interest to adopt revised articles for the Company in the form hereof; and

NOW THEREFORE, the undersigned being a duly authorized representative of the members, pursuant to the provisions of Florida Statutes Section 608.411, adopts the following Amended and Restated Articles of Organization of SAN PABLO PROPERTIES, LLC, a limited liability company duly organized and existing under the laws of the State of Florida as filed with the Florida Department of State on May 5, 2009 (the "Amended and Restated Articles of Organization"):

**ARTICLE I**

**NAME**

##### DURATION AND CONTINUATION

The period of the Company's duration shall commence with the filing of the Original Articles of Organization with the Secretary of State, and shall continue perpetually, unless terminated in accordance with the Company's Operating Agreement.

#### ARTICLE V

##### MANAGEMENT

Each Manager(s) shall also have the rights and responsibilities described in the Operating Agreement of the Company, if applicable. Each Manager(s), other than the initial Managers, shall be appointed or elected solely as provided in the Operating Agreement.
