## ARTICLES OF ORGANIZATION OF RIVER GUY MANAGEMENT, LLC

### ARTICLE I Name of Company

River Guy Management, LLC

### ARTICLE II Business of Organization

The limited liability company may engage in the business of real estate management, and leasing, and may also engage in any other lawful activity or business permitted under the laws of the United States and of the State of Florida.

### ARTICLE III Principal Place of Business
