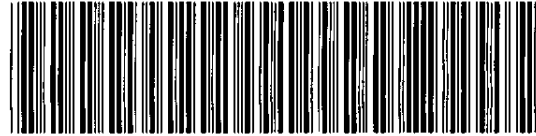



ARTICLE I
NAME AND ADDRESS

The Company shall be effective on filing and shall have perpetual duration.


