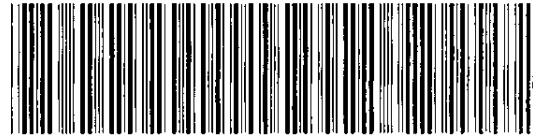

ARTICLE I - Name:

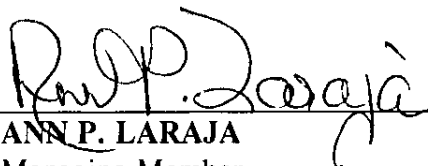
ARTICLE VII - Members Rights to Continue Business:
