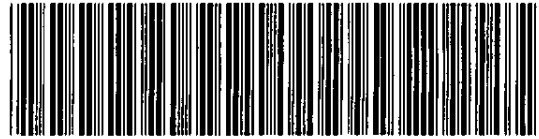



**SIXTH:** The person or persons executing these Articles of Organization is (are) a member or the authorized representative of a member of the Limited Liability Company.

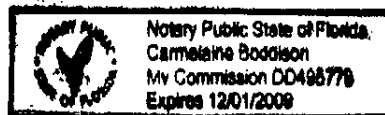

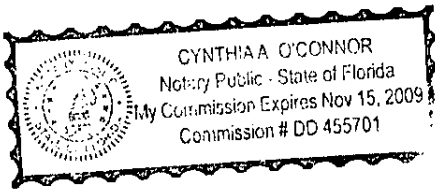
