ARTICLES OF ORGANIZATION

ARTICLE I

ARTICLE VI**MANAGER**

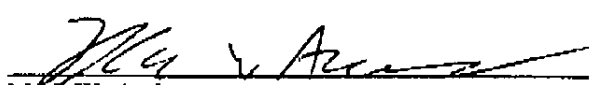
