ARTICLE I - Name

The name of the professional limited liability company is Pediatric Psychology Associates, P.L. (the "Company").

The purposes for which the Company is formed are:

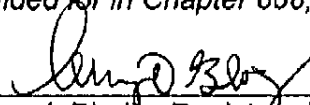
