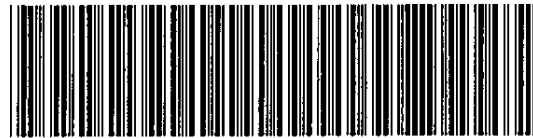

**ARTICLES OF ORGANIZATION OF  
348 59<sup>th</sup> STREET, L.L.C.**

**ARTICLE I  
NAME**

The name of this Limited Liability Company shall be: **348 59<sup>th</sup> STREET, L.L.C.**

**ARTICLE II  
PURPOSE**

The power to alter, amend or repeal these regulations shall be vested in all the members of this company.


**ARTICLE VI


