**ARTICLES OF ORGANIZATION
OF
THOMAS INSURANCE SERVICES, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be THOMAS INSURANCE SERVICES, LLC ("company").

ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the company is 3235-B U.S. Hwy. 27/441, Fruitland Park, FL 34731.

ARTICLE III - DURATION

The company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State or on another effective date as specified. The company's existence shall be perpetual unless the company is dissolved earlier as provided in these Articles of Organization or in the Operating Agreement.

ARTICLE IV - REGISTERED AGENT AND OFFICE

The name of Company's initial registered agent in Florida is John C. Thomas. The address of Company's registered office in Florida is 3235-B U.S. Hwy. 27/441, Fruitland Park, FL 34731.

ARTICLE V - ADMISSION OF NEW MEMBERS

Except as set forth in the Operating Agreement, no additional members shall be admitted to the company except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members.

ARTICLE VI - MANAGEMENT

The company shall be managed by a manager in accordance with Operating Agreement adopted by the members for the management of the business and affairs of the company. The Operating Agreement may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 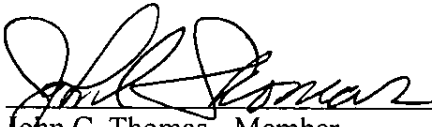


ARTICLE VII – LIMITATION ON AGENCY AUTHORITY OF MEMBERS

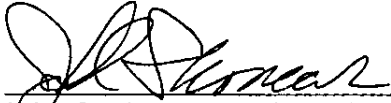
