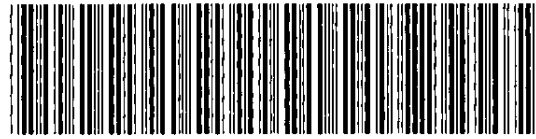

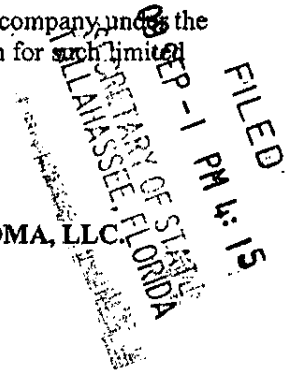

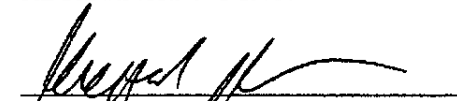


ACCEPTANCE BY REGISTERED AGENT
