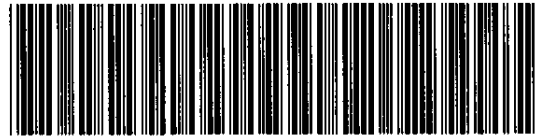

Pursuant to the provisions of section 608.441, Florida Statutes, this limited liability company adopts the following Articles of Dissolution to its Articles of Organization:

**FIRST:** The name and address of this Company is **INTERNET MARKETING TECH GROUP LLC**, 3206 Cleopatra Court, Saint Cloud, Florida 34771.

**SECOND:** The date of the adoption of these Articles of Dissolution is 19 October 2009.

**THIRD:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421.
