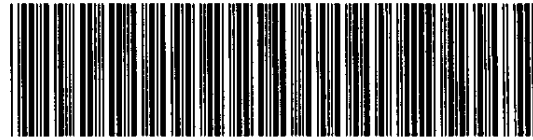

DAC Properties operating.

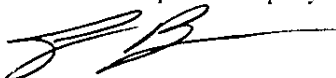
