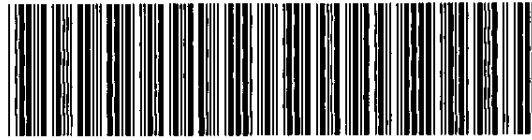

2. The name of the Company shall be amended to read as follows:



3. These Articles of Amendment to the Articles of Organization of the Company shall be effective upon the date of filing with the Secretary of State of the State of Florida.


