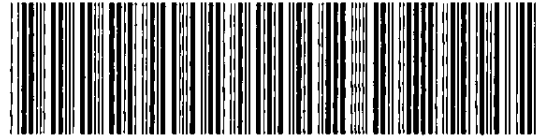

The undersigned, acting as organizer of this professional limited liability company pursuant to Chapter 621 of the Florida Statutes, hereby forms a professional limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for such limited liability company:

ARTICLE I - Name

ARTICLE VI - Purpose and Members

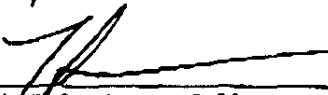
