3. The Company shall be Manager managed and the following is the name and address of the Manager of the Company:

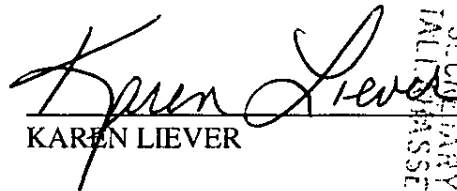
