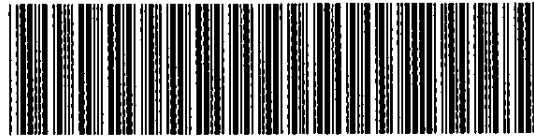

FIRST: The name and address of this Company is **123 TOWING LLC**, 17133 Southwest 137th Place, Miami, Florida 33177.

SECOND: The date of the adoption of these Articles of Dissolution is 3 February 2010.

THIRD: The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 608.4421. The remaining property and assets have been distributed among its members in accordance with their respective rights and interests.
