The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge and file the following Articles of Organization.

**ARTICLE I -- NAME**

The name of the limited liability company shall be **9231 SW 776 TERR, LLC**, a **limited liability company** (the "Company").

**ARTICLE II -- ADDRESS**

(a) The principal address of the Company shall be 8950 NW 27 Street, Doral, Florida 33172.

the Company. The Regulations and the Operating Agreement, if any, shall determine the  
manner in which such the Manager(s) are elected and appointed, and may contain any  
provisions for the regulation and management of the affairs of the company not

extent permitted by the laws of the State of Florida.

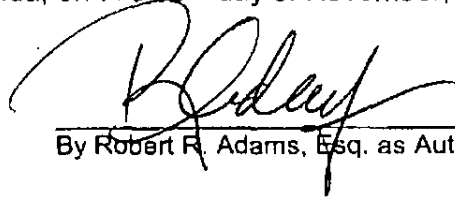

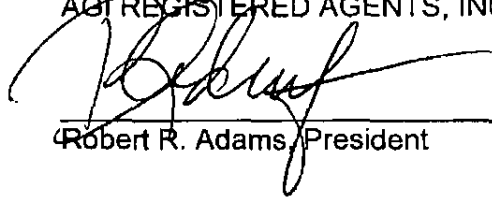
