ARTICLES OF ORGANIZATION

OF

ARTICLE I

Name of Limited Liability Company

The name of this limited liability company is EQUITY BUILDERS CA, LLC (the "Company"), with its principal place of business being located at 53 Village Centre Place., Suite 300, Mississauga, ON. L4Z 1V9, and the mailing address is the same.

ARTICLE II

Duration

The Company shall exist from the date of filing of these Articles of Organization with the Department of State until the earlier of fifty (50) years from the date of filing or the occurrence of any of the events specified in Florida Statutes Section 608.441, unless continued by unanimous consent of all of the remaining members.

ARTICLE III

Purpose

The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

ARTICLE IV

Registered Agent and Office

ARTICLE VII
Management of the Company

The transferee shall be entitled to receive only the share of profits or other compensation by way of income, and the return of contributions to which the transferring member otherwise would be entitled by virtue of membership.

ARTICLE XI
Certificated Interests

The members' interests in the Company shall be evidenced by certificates.

ARTICLE XII
Contracting Debts

All contracting debts of the limited liability company require the approval of one of the managers.
