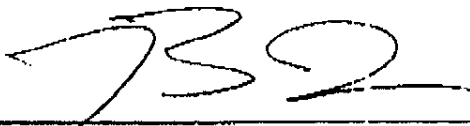
ARTICLE V

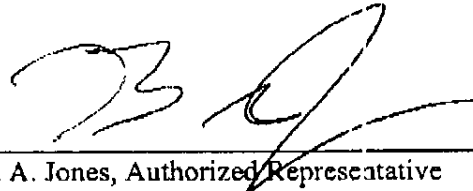
